On July 06th, 2022, the **OIL TEST INTERNACIONAL** inspector did attend at the facilities of **ANTIGUAS BODEGAS DE IMFERRA**, located at **SAN PEDRO SULA, CORTES, HONDURAS**. to carry out the inspection of 1x40' Container stuffed with **1,540 boxes containing MON ENERGY CAN**

The inspection commenced on **July 6th, 2022, from 07:30 to 17:30 hours**, and was carried out jointly with the support of **CERVECERIA HONDUREÑA** personnel.

Representatives from CERVECERIA HONDUREÑA, EXA and Oil Test International did attend and witnessed the opening of the container unit and destuffing of all the cargo. Once the container was opened, it was destuffed by Cerveceria Hondureña staff, a total of 20 pallets of 70 boxes each and 1 pallet of 48 boxes were assembled with the boxes in apparent good condition, the boxes were randomly inspected due to the personnel in charge to destuff the cargo refused to cooperate with the box-by-box inspection, stating that their instructions were only to destuff the cargo. Once the destuffing was finished and assembled in pallets, we proceed to wait for the presence of the quality department of Cerveceria Hondureña to proceed with a more thorough inspection, but their decision was to take the total of the cargo as damaged.
