

TRANSPORT CONTRACT ADDENDUM NO. 1

VENDOR AGREEMENT

This Addendum to Transport Agreement of July 23, 2019 between EXA, S.A. (hereinafter called "Operator") and Hapag-Lloyd AG (hereinafter called "Client") is effective June 01, 2020. This Addendum upon complete execution by both parties will complement and/or supersede any previous agreements between Operator and Client.

Whereby the following is mutually agreed:

1) TRANSPORT AGREEMENT 1 (ONE YEAR) CONTRACT EXTENSION (Subject to Covid-19 agreement)

SEVENTH: TERM - This agreement shall be effective for a four (4) year term, commencing on July 23, 2019.

After completion of the aforementioned four (4) year term, the contract shall renew automatically for an additional year, unless any of the parties gives the other written notice of its intention not to renew the agreement. The notice shall be send 90 days in advance of the completion of the four-year term.

If automatically renewed pursuant to the above paragraph, the agreement shall continue to exist thereafter indefinitely until any of the parties gives the other notice of its intention to terminate the agreement. Such notice of termination may be send by any of the parties, at any time, with 60 days in advance of the date of effective termination.

2) TRANSPORT FREE POOLS / HONDURAS – Exhibit D

HAPAG-LLOYD and vendor may enter into a Free Pool Agreement subjected by written approval from both parties and with T&C stipulated on Transport Agreement.

TERMS OF FREE POOL AGREEMENT:

Vendor will provide free In/Out Gate on all CH Inland Movements

Vendor will undertake to water wash/clean equipment for export booking at no additional charge to HLAG

Vendor will report all equipment in their possession within 3 hours of arrival at their facility

Vendor will perform minor repairs on equipment required for export bookings at no additional cost to HLAG

Vendor must report all equipment damages within 3 hours of arrival at their facility

HLAG will commit to providing the allotted number of equipment to meet demand


