On August 27<sup>th</sup>, 2022, the **OIL TEST INTERNACIONAL** inspector did attend at the facilities of **YONKER RECONCO**, located at **SIGUATEPEQUE, COMAYAGUA, HONDURAS**. to carry out the inspection of 1x40' Container stuffed with **185 Pieces of Used Auto Parts**.


The inspector arrived at the facilities on August 27 at 17:50, Upon arrival, the inspector found that the seal had already been broken, the container doors had been opened, and the cargo had begun to be discharged.

During the discharging of the cargo, photographs of the process were taken.

It was not possible to determine the quantity and condition of the pieces because the Yonker personnel in charge of discharging, determined that they would only discharge the cargo and the count and damage verification would take place until Monday, August 29, 2022.

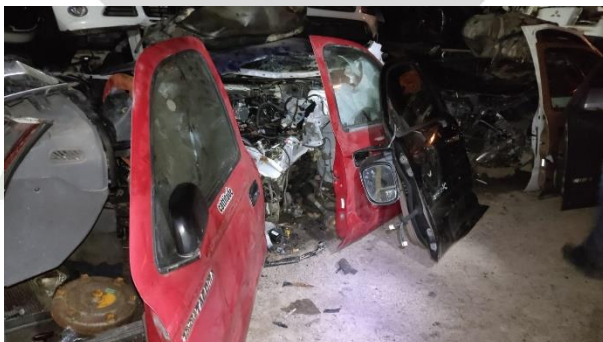
